A Natura Impact Statement has also been prepared and has been submitted to the Board in respect of the proposed road development under Part XAB of the Planning and Development Act 2000 (as amended).

The N6 Galway City Ring Road 2018 is classed as "strategic infrastructure development" under the terms of the Planning and Development Acts 2000 to 2018. A fee of €50 must be paid in respect of any observations/submissions made to An Bord Pleanála in respect of any local authority strategic infrastructure development application.

This fee does not apply to certain prescribed bodies or to property owners and others with a legal interest in land who are objecting to compulsory acquisition of land in which they have such an interest in a compulsory acquisition case.

5. The Board may, in relation to an application for approval under section 51 of the Roads Act, 1993 (as amended), by order, approve the proposed road development or any part thereof, with or without conditions or modifications, or it may refuse to approve such development or any part thereof.

A person may question the validity of any decision by An Bord Pleanála on a proposed road development by way of an application for judicial review under the Rules of the Superior Courts (and in particular Order 84 of the Rules of the Superior Courts contained in S.I No. 15 of 1986 as amended) and in accordance with sections 50, 50A and 50B of the Planning and Development Act 2000-2018.

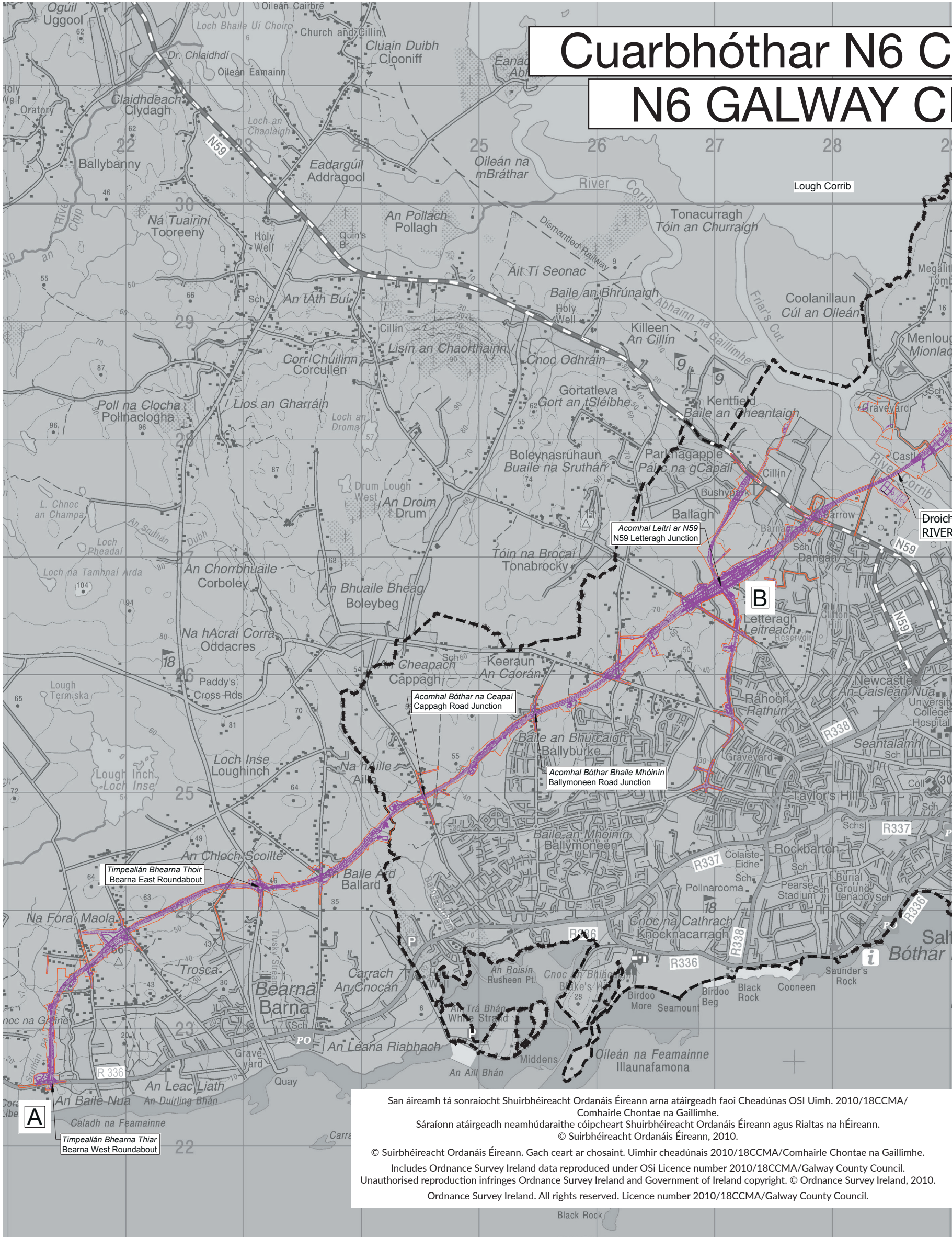

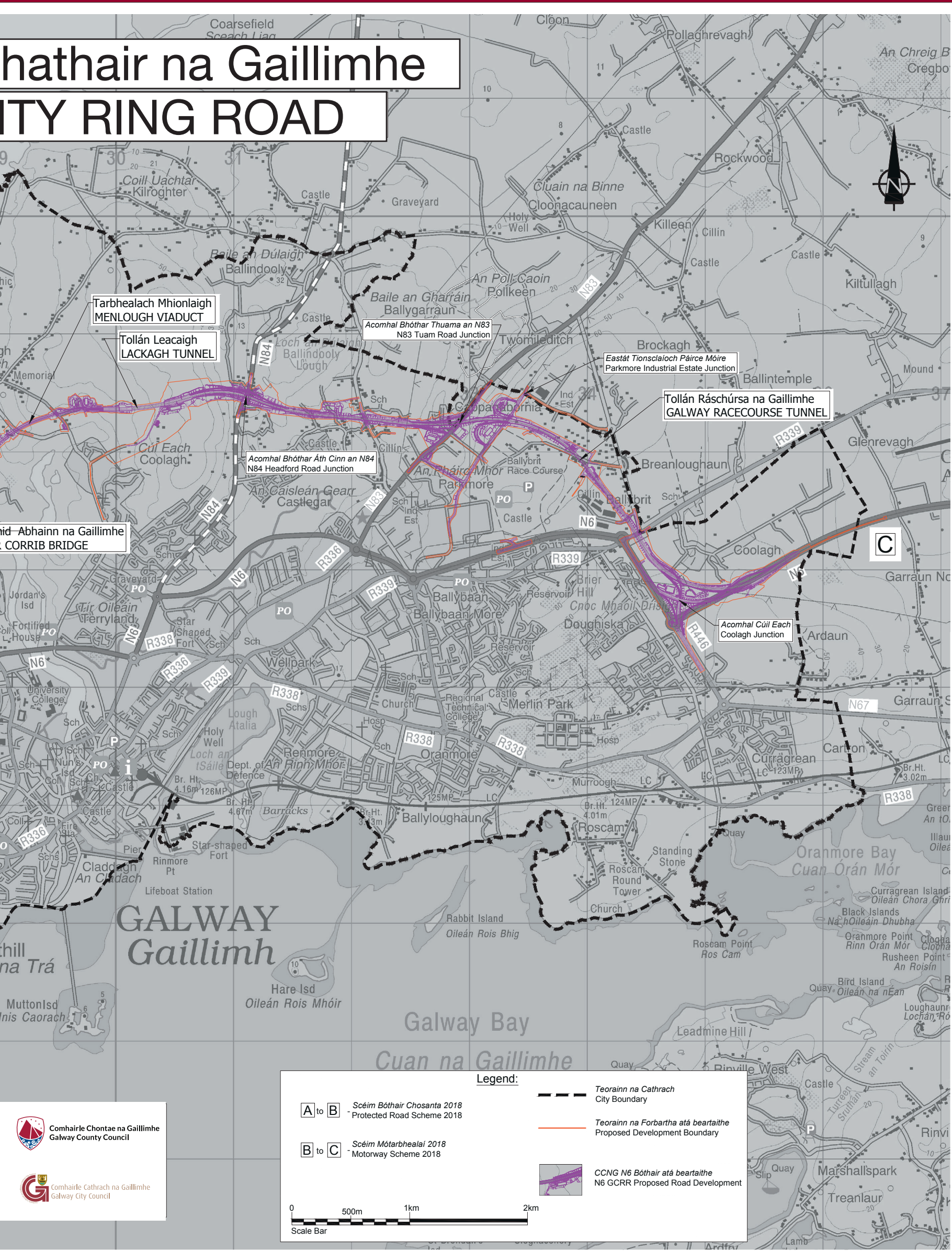
